Minutes of meeting of the Approval Committee of Moradabad SEZ held under the Chairmanship of Shri A. Bipin Menon, Development Commissioner (DC), Noida SEZ at 12:00 PM on 13/01/2023 through video conferencing.

A. The following members of the Approval Committee were present through video conferencing during the meeting:-

B. Besides, during the meeting S/Shri (i) Rajesh Kumar, Dy. Development Commissioner, Noida SEZ (ii) Kiran M. Mohadikar, Specified Officer (Customs), Moradabad SEZ, (iii) Vikas, Asstt. Development Commissioner, Moradabad SEZ and (iv) Joseph Upadhyay, Stenographer, Moradabad SEZ were also present to assist the Approval Committee. It was informed that the stipulated quorum for holding the meeting is available and meeting can proceed.

C. At the outset, the Chairman welcomed the participants. After a brief introduction, the agenda was taken up sequentially. After detailed deliberations amongst the members of the Approval Committee as well as interaction with the applicants / representatives of the units, the following decisions were unanimously taken:-

	As no reference against the decisions of the Approval Committee meeting held on 08/12/2022 has been received, the Approval Committee took note of the same and accordingly, Minutes of the meeting held on 08/12/2022 were unanimously ratified.



02.	<p>Proposal for creating additional facilities by the unit.</p> <p>2.1 M/s C. L. Gupta Overseas LLP :</p> <ol style="list-style-type: none"> 1. The proposal of M/s C. L. Gupta Overseas LLP for opening a fair price shop under corporate social responsibility (CSR) for distribution of gifts and other needs to the staff and workers of their unit was placed before Approval Committee. 2. Shri Kala Mukundan, authorised representative from the unit appeared before the Approval Committee. He informed that the fair price shop facility will be available for regular/ permanent employees of the unit wherein they would be passing on the benefits given by their overseas buyers for welfare of the factory workers/ employees. Shri Mukundan further informed that they would be demarcating an area of 220 square feet inside their unit premises for creating the proposed facility. 3. The Approval Committee, after due deliberations, approved the proposal of M/s C. L. Gupta Overseas LLP for opening a fair price shop under CSR for distribution of gift and other needs to the staff and workers of their unit. They will procure the blocks or slabs of Marble/ Stone then design, cut, polish, finish and fit the products as per buyer requirement in their premises. 3.
